## **1. About Us**

Chelmer Surgical Supply Ltd is a UK-based manufacturer of Class III sterile neurosurgical patties, operating under UKCA certification and compliant with the UK Medical Devices Regulations 2002 (as amended). We supply healthcare institutions only.

## **2. Scope of Supply**

We manufacture and supply pre-defined variants of sterile neurosurgical patties. Products are supplied from stock or made-to-order, depending on availability.

All products are intended for professional surgical use only by qualified healthcare professionals. They are not suitable for consumer or home use.

## **3. Ordering and Contract Formation**

We only accept formal Purchase Orders (POs) issued by recognised healthcare institutions. No purchases are accepted via online checkout or consumer channels.

A binding contract is formed once we accept your PO and confirm fulfilment. We reserve the right to decline orders at our discretion.

## **4. Lead Times and Delivery**

Standard dispatch is within 1–2 working days from order confirmation. In cases of out-of-stock, lead times may extend up to 2 weeks.

All deliveries are made via tracked courier services with proof of delivery (POD), GPS tagging, and photo evidence.

Risk in the goods passes to you upon confirmed delivery. CSS Ltd is not responsible for delays or loss once goods are in the courier's possession.

## **5. Returns and Refunds**

Due to the sterile nature of our products, returns are not accepted unless there is a substantiated product issue or regulatory concern.

If you believe a product is defective or may have caused an adverse incident, contact us immediately. All such matters will be handled in line with official complaints and vigilance procedure and, where appropriate, reported via the MHRA.

## **6. Product Warranty and Limitations**

Our products carry a 5-year shelf life from the date of manufacture when stored under recommended conditions.

We make no warranties beyond those required by law. Use of our products outside their Intended Use, as outlined in the Instructions for Use (IFU), is strictly at your own risk.

CSS Ltd accepts no liability for misuse, off-label use, reprocessing, or failure to follow applicable clinical guidance.
